

H. A. R. GIBB (1895 - 1970)

Wilfred Cantwell Smith dalam kunjungannya ke IAIN Sunan Kalijaga Yogyakarta bulan Juli 1973 antara lain memberitakan bahwa H. A. R. Gibb telah meninggal dunia pada tahun 1970.

Berita ini menarik perhatian kami, sebab H.A.R. Gibb dapat dianggap sebagai Orientalist terbesar pada pertengahan abad kedua puluh ini yang sejajar dengan Sylvestre de Sacy pada abad ke 19 dan Noldeke serta Ignace Goldziher pada permulaan abad kedua puluh. Perhatian yang terbesar dipusat kannya tentang studi bahasa Arab dan Islam, sehingga karyanya sangat banyak yang sudah dipublikasikan. Pengaruhnya sangat besar baik bagi murid-muridnya sendiri maupun bagi sarjana-sarjana lain yang berminat menyelidiki hasil-hasil karyanya, terutama dari kalangan sarjana-sarjana Barat. Oleh karena itu tidak mengherankan apabila dua orang sarjana Stanford J. Shaw dan William R. Polk sengaja mengumpulkan karya-karya Gibb yang dimuat dalam majalah-majalah Ilmiyah kemudian dibukukan menjadi satu buku yang berjudul STUDIES ON THE CIVILIZATION OF ISLAM yang diterbitkan pada tahun 1962. Tiga tahun kemudian untuk menghormati jasa-jasanya dalam bidang studi bahasa Arab dan Islam George Makdisi mengumpulkan karya-karya sarjana-sarjana terkenal didalam sebuah buku yang berkaitan dengan studi bahasa Arab dan Islam, kemudian buku tersebut diberi judul ARABIC AND ISLAMIC STUDIES IN HONOR OF HAMILTON A.R. GIBB yang diterbitkan pada tahun 1965.

Dalam Indonesia banyak karya Gibb dijadikan bahan bacaan wajib di universitas-universitas terutama yang berhubungan dengan studi Islam, bahkan di IAIN sendiri buku Modern Trends in Islam dijadikan bahan bacaan utama dalam mata pelajaran Aliran-Aliran Islam Modern.

Apabila disini dikemukakan tentang H.A.R. Gibb bukan berarti kami setuju kepada semua pemikiran-pemikirannya, tetapi sebagai seorang yang tertarik untuk menyelidiki karya-karya sarjana-sarjana Barat kami merasa perlu untuk mengemukakannya, dengan harapan akan mengajak sarjana-sarjana angkatan muda Indonesia untuk berpikir lebih kritis terhadap karya sarjana Barat. Bagi mereka yang lama mempelajari agama Islam dari sumber aslinya Quran dan Hadits serta karya-karya ulama-ulama Islam yang mu'tabar tidak begitu sukar untuk membandingkan alam fikiran Barat dengan alam fikiran ulama-ulama Islam, tetapi bagi sarjana-sarjana yang belum pernah mempelajari Islam secara mendalam dari sumbernya yang asli, sukar dapat memberikan penilaian terhadap karya-karya sarjana-sarjana Barat, bahkan bisa tertarik kepada alam fikiran sarjana-sarjana Barat itu sendiri.

Slapakah H.A.R. Gibb ?

Sir Hamilton Alexander Rosskeen Gibb dilahirkan di Alexandria Mesir pada tanggal 2 Januari 1895. Ayahnya Alexander Crawford Gibb adalah putra dari John Gibb dari Gladstone, Renfrenshire Scotland yang pada waktu itu menjadi manager pertanian untuk Aboukir Land Reclamation Company. Sesudah ayahnya meninggal tahun 1897, maka ibunya Jane Ann Gardner dari Greenock Scotland berangkat ke Alexandria dan bekerja sebagai guru di Church of Scotland Girl's School. Hamilton dalam usia lima tahun dipulangkan ke

Scotland untuk memasuki sekolah dasar. Sesudah belajar empat tahun maka dia memasuki Edinburgh High School tahun 1904 dan terus belajar disana sampai tahun 1912. Dalam waktu yang cukup lama ini dia dua kali pergi ke Mesir untuk menikmati liburan musim panas. Disamping belajar di sekolah dia juga menambah pengetahuannya dalam mata pelajaran bahasa Perancis, Jerman dan ilmu alam. Pada tahun 1912 dia memasuki Edinburgh University dan pada tahun pertama di universitas tersebut terdapat mata pelajaran bahasa-bahasa Semit, Hebrew, Arab dan Aram. Profesor dalam mata kuliah bahasa Hebrew A.R.S. Kennedy merupakan guru besar yang sangat baik bagi Hamilton, sedangkan bahasa Arab hanya diajarkan oleh seorang lektor yang masih muda bernama Edward Robertson (untuk selanjutnya menjadi guru besar dalam mata pelajaran bahasa-bahasa Semit di Manchester) yang merupakan mata pelajaran yang belum begitu mendapat perhatian. Pada tahun 1913 ibunya meninggal dunia ketika dia masih berada ditingkat II Universitas Edinburgh.

Pada waktu itu Universitas Edinburgh sebagaimana universitas-universitas lain di Inggris mempunyai suatu seksi tempat melatih perwira-perwira militer terutama dalam bidang artillery. Hamilton mengajukan lamaran untuk bidang ini dan diterima untuk dilatih sebagai perwira artillery. Sewaktu pecah perang dunia pertama tahun 1914, semua mereka yang mengikuti latihan artillery dimasukkan kedalam kesatuan artillery. Pada waktu ini Hamilton masih berusia 19 tahun, dan dia ditugaskan di Artillery Officers' Training Unit sebagai instruktur dan terus bertugas disana sampai dia dipindahkan ke South Midland Brigade yang didalam tugas ini dia berangkat ke Perancis pada bulan Februari 1917. Dia bertugas sebagai anggota angkatan perang disana dan di Italia sampai perang berakhir tahun 1918.

Pada musim panas tahun 1919 dia memperoleh tingkat keahlian dalam perang dari Edinburgh University kemudian dia memasuki London School of Oriental Studies dalam program MA untuk mata pelajaran bahasa Arab. Pada tahun 1922 dia menyelesaikan studinya yang berhasil memperoleh titel MA dalam mata pelajaran bahasa Arab. Setahun sebelumnya yaitu pada tahun 1921 dia diangkat sebagai asisten dalam mata pelajaran tersebut untuk selanjutnya menjadi asisten Professor dari Sir Thomas Arnold. Pada tahun 1922 dia kawin dengan Melen Jessie Stark, yang pada mulanya bertemu ketika dia pulang ke Scotland dalam usia lima tahun, yang menghasilkan dua orang putra masing-masing Ian (lahir tahun 1923) dan Dorothy (lahir tahun 1926). Pada tahun 1926-1927 dia memulai suatu perjalanan panjang kenegeri-negeri Timur Tengah dan mengambil kesempatan untuk mempelajari bahasa dan kesusasteraan Arab modern, dan dia juga mempergunakan waktunya untuk berkunjung ke beberapa negeri di Afrika Utara. Pada tahun 1929 dia diangkat sebagai staf ahli dalam bidang bahasa Arab dan kesusasteraannya, dan pada tahun 1930 ketika Professor Sir Thomas Arnold meninggal dia langsung diangkat sebagai Guru Besar Bahasa Arab. Dia juga menggantikan Sir Thomas Arnold sebagai editor Encyclopedia of Islam sampai tahun 1955 dan kemudian menjadi editor utama dalam menyempurnakan (revised edition) Encyclopedia of Islam.

Hamilton menjadi Professor dalam mata pelajaran bahasa Arab di Universitas London dari tahun 1930 sampai dengan tahun 1937, disamping itu juga menjadi Professor bahasa Arab di St. John's College, Universitas Oxford dari tahun 1937 sampai dengan tahun 1955. Pada tahun 1955 dia diangkat

sebagai Professor di Harvard University, dan dua tahun kemudian dia dilantik sebagai Direktur Center for Middle Eastern Studies. Pada tahun 1964 dia mengundurkan diri sebagai guru besar tetapi terus melanjutkan tugasnya sebagai pimpinan Center for Middle Eastern Studies yang dijabatnya sejak tahun 1957. Dalam usia yang lanjut ini dia masih membagi waktunya untuk Cambridge, Massachusetts dan Oxford.

Tanda-tanda jasa yang pernah diterimanya ialah Knight Bachelor dari Inggris (tahun 1954), Comander of Orange Nassau (Belanda), Legion of Honor (Perancis). Dia termasuk anggota kehormatan British Academy, Danish Academy, American Philosophical Society dan anggota kehormatan American Academy of Arts and Sciences dan mediaeval Academy of America. Disamping itu dia juga anggota pembantu Institut d'Egypte, anggota Academy of Arabic Language Cairo, Arabic Academy Damascus dan Arabic Academy di Iraq.

Tulisan-tulisanannya cukup banyak yang ditulis semenjak tahun 1923. Pada umumnya tulisan-tulisan itu ada yang berbentuk buku-buku atau artikel-artikel dalam majalah-majalah ilmiah, ada tulisan-tulisan yang berbentuk books reviews dan ada pula tulisan-tulisan yang berkaitan dengan penghormatan terhadap seseorang sarjana yang baru meninggal dunia.
